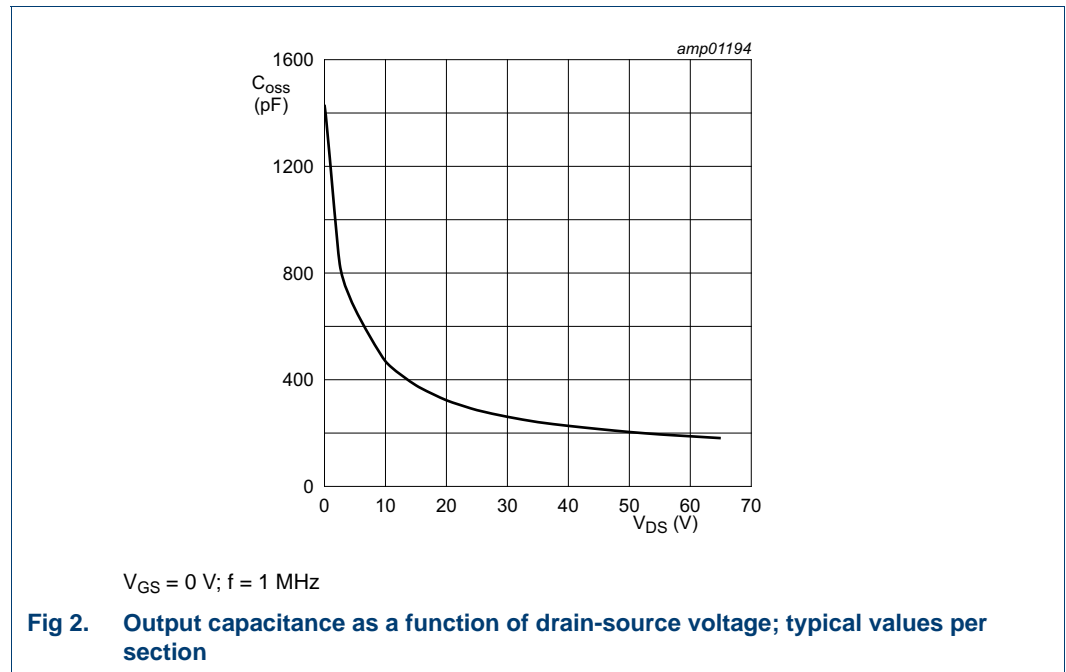

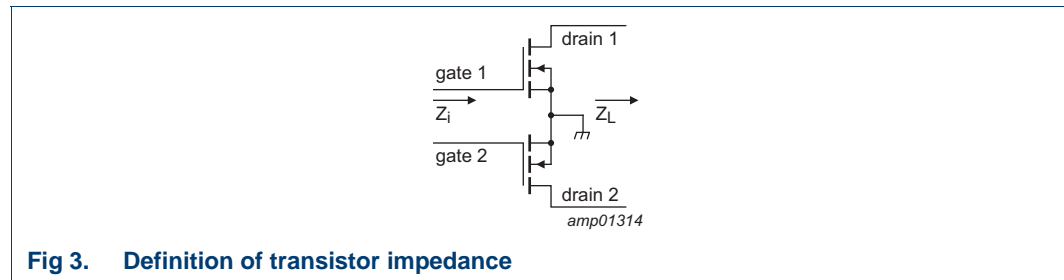

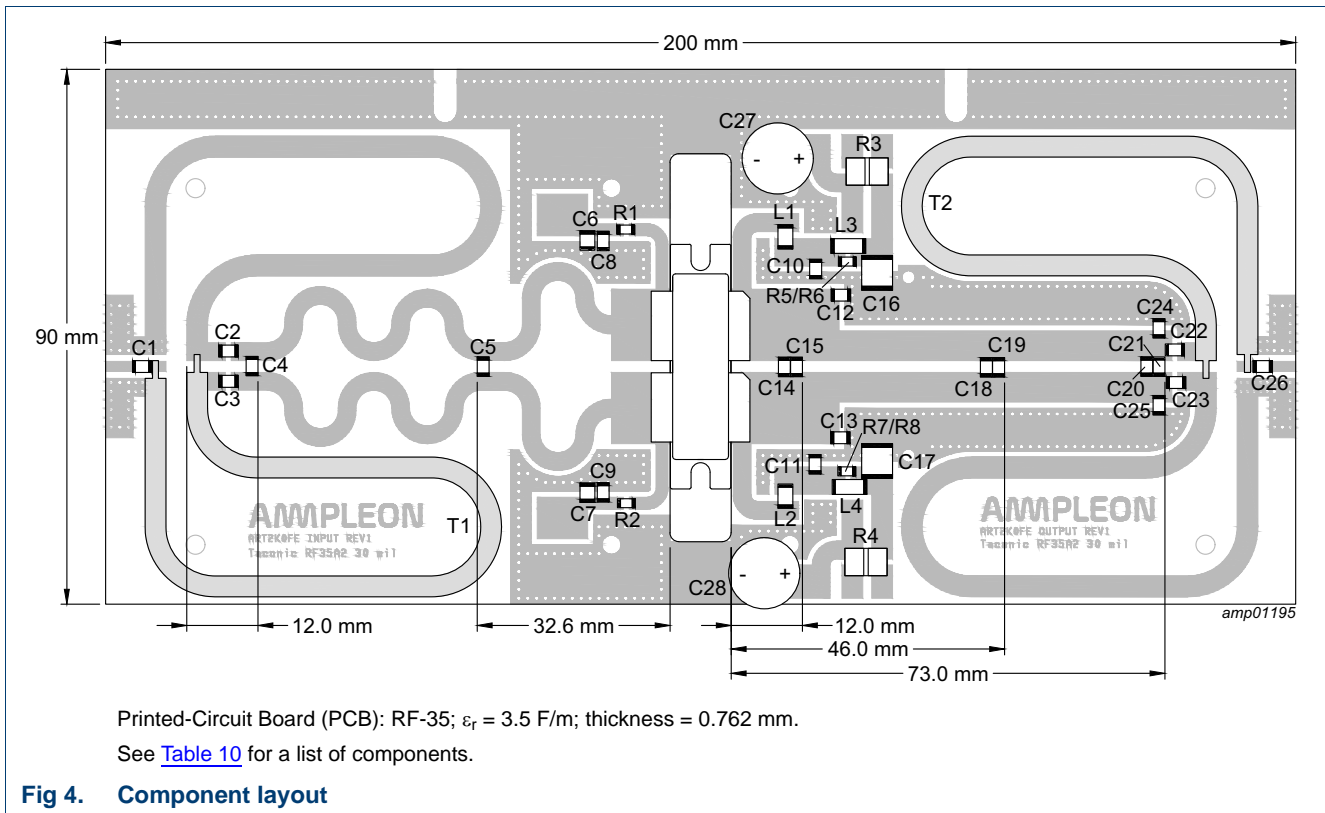


Fig 4. Component layout

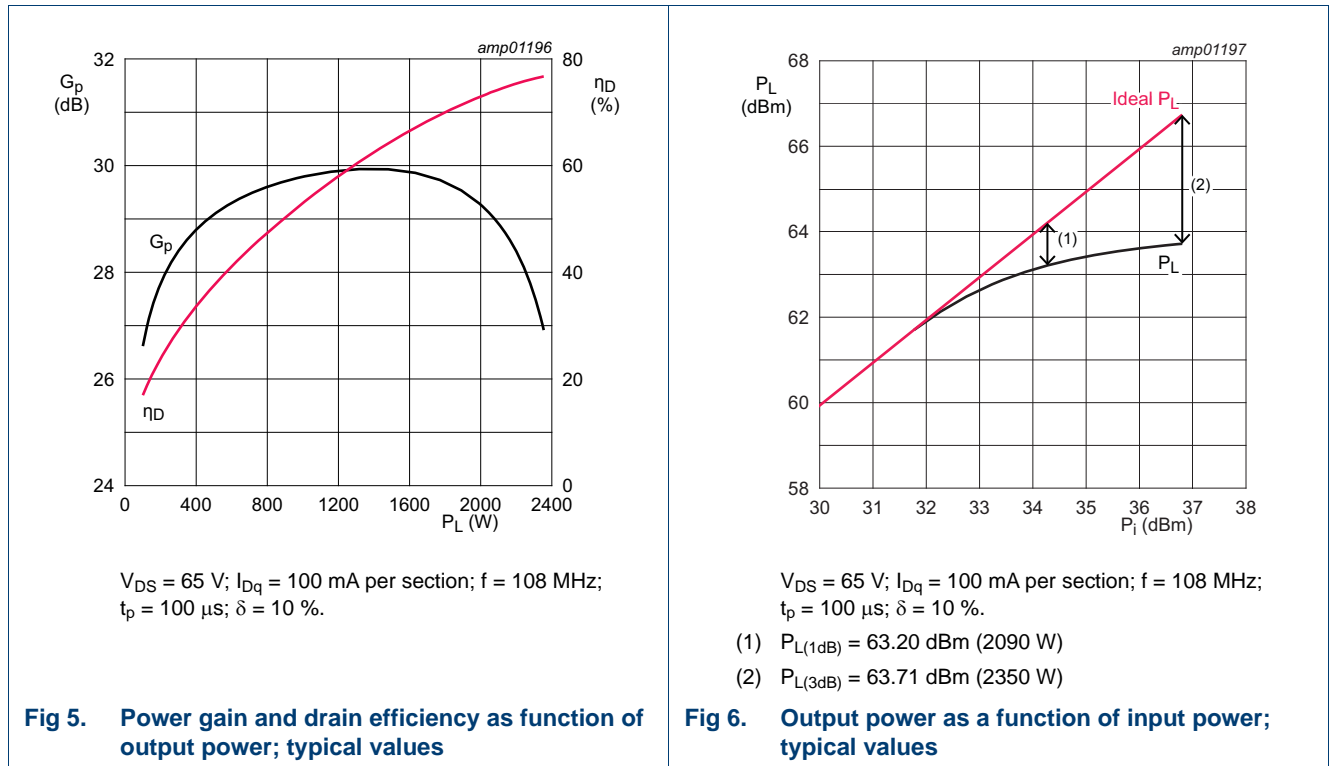

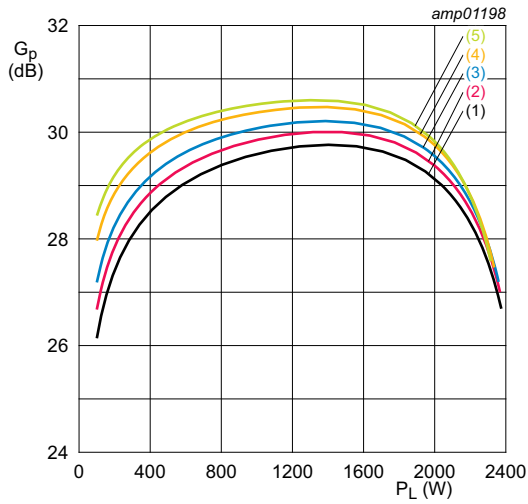

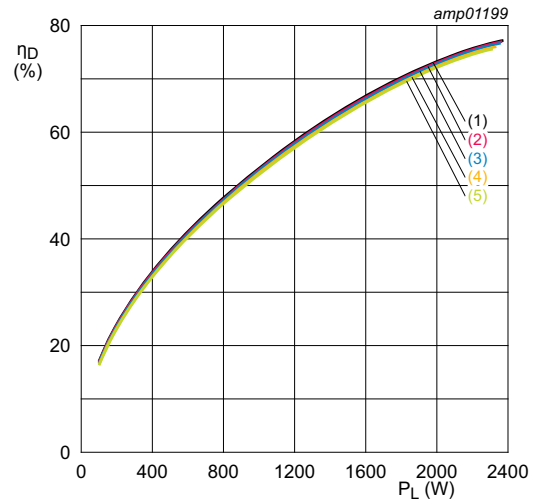

**Fig 7. Power gain as a function of output power; typical values**

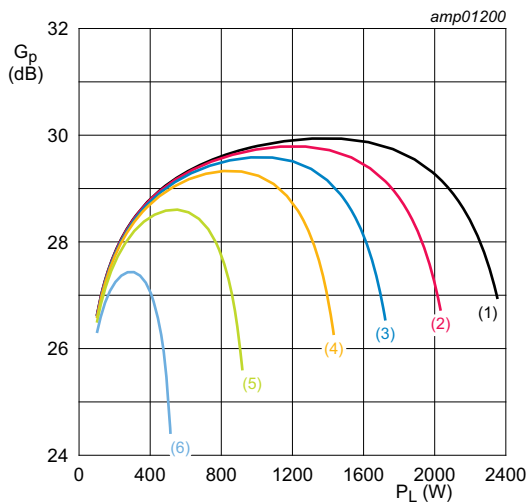

**Fig 8. Drain efficiency as a function of output power; typical values**

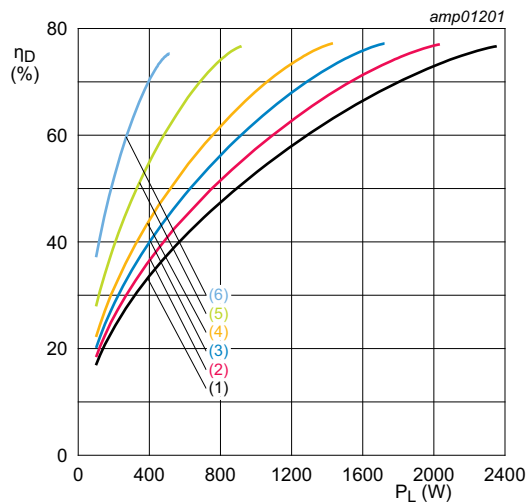

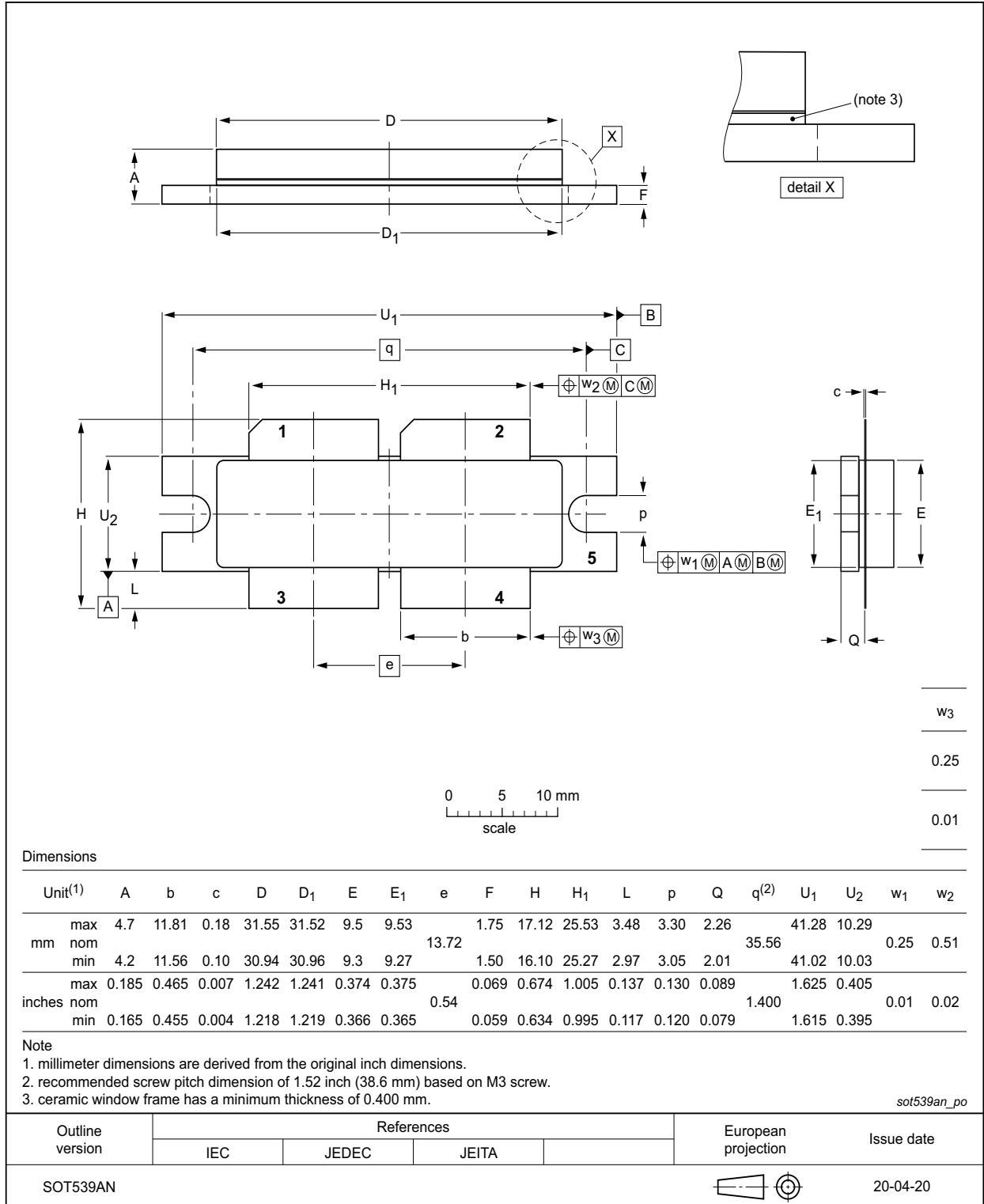


Fig 11. Package outline SOT539AN
